Podiatry Schedule of Fees will be periodically reviewed and may be updated from time to time.

Billing Rules:

- Prices in the above table are representative of one foot. If a pair is provided or both feet are treated the item code will be billed twice.
- The ADF limit Orthoses to one pair. The referring On-base Medical Officer must approve all requests for additional Orthoses prior to supply.
- Supply, fitting and complete initial components including plain covers and posts are included with all orthosis item numbers.
- Where an item number is billed twice, the provider must specify left or right on the invoice/account.
- Only one initial consultation can be claimed per episode of care.
- Subsequent consultations cannot be claimed on the same day as an initial consultation for the same patient.
- Multiple subsequent consultations cannot be claimed on the same day.
